Submitting an Article:

- 1) To be considered for publication, all articles must be educational and informative, rather than promotional. A company may be mentioned and its services described as a background for more general information of value to our readers. "Infomercials" will not be accepted.
- 2) Newsletter articles generally average 1,500 to 2,000 words in length. Longer or shorter pieces will be considered if they meet the goals and standards of the newsletter.
- 3) Each article should include a *title* if you have one in mind, *your name* as you want it to appear in the byline and a *short author biography* of 50 words or less. Keep any formatting simple (paragraphs, headings, subheadings, bulleting, numbering). The newsletter uses spot-colour only so any graphs and tables should be reproducible in a two-colour format.
- 4) Deadline for submission is 5 p.m. on the following dates in 2007 (subject to change): *January 4, March 1, May 3, July 5, August 30, and November 1*. Please be aware of these deadlines especially if your article requires company approval(s) prior to submission. Articles should be submitted by email in Word or .rtf format to info@canadianhedgewatch.com. Any graphics (e.g. graphs and charts) included in your article should be attached separately in JPEG or EPS format at 300dpi minimum to ensure quality reproduction.
- 5) Submissions will be assessed by the CHW editorial board which has final control over publication. Articles accepted for publication become the property of Canadian Hedge Watch Inc., along with reprint rights and electronic rights.
- 6) Articles will be copy-edited by CHW prior to publication and may be returned to the author for re-writing and/or approval if major changes are required. CHW maintains editorial control.
- 7) While every effort will be made to ensure the accuracy of information published, Canadian Hedge Watch Inc., its staff, management and shareholders will not be responsible for the content of individual articles. Any liability incurred as a result of the article and opinions therein, whether expressed or implied, is the sole responsibility of the author.
- 8) Include full author contact information (phone, fax, email address & street address) with your submission. If your article is published, we'll send you a complimentary copy of the newsletter.
